

MEMORANDUM OF UNDERSTANDING

KNOW ALL MEN BY THESE PRESENTS:

This agreement entered into 29th day of August 2023 in Bandung City, West Java, Indonesia and by and between: **Quezon City University** hereinafter referred to as "Quezon City University", and **STIKES Bhakti Pertiwi Indonesia** hereinafter referred to as "STIKES Bhakti Pertiwi Indonesia", collectively referred to as "the Parties".

WITNESSETH THAT:

WHEREAS, in the interest of educational cooperation and in the spirit of making significant contribution to the international and intercultural education of people, **Quezon City University** and **STIKES Bhakti Pertiwi Indonesia** to establish a framework for academic, research, and cultural exchange between the Parties. Both institutions, recognizing the benefits of international cooperation, aim to foster mutual understanding, enhance scholarly activities, and provide cross-cultural experiences for their respective communities;

WHEREAS, the parties acknowledge that such understanding will bring not only the professional members of their respective institutions, but also the students and the people they serve closer together in their pursuit of educational ideals;

WHEREFORE, in consideration of the above premises, the parties hereby agree as follows:

1. The **Quezon City University** and **STIKES Bhakti Pertiwi Indonesia** shall assist one another to carry forward joint research collaboration and publication on mutually-agreed upon areas of study;
2. The **Quezon City University** and **STIKES Bhakti Pertiwi Indonesia** shall enter into an agreement creating a program of exchange of their respective professional members and students for instructional, research and cultural purposes. The agreement covers all disciplines offered by the respective institutions;
3. The **Quezon City University** and **STIKES Bhakti Pertiwi Indonesia** shall explore the potential of co-sponsoring international conferences, trainings, and academic exchanges in areas of joint interests, the arrangements of which shall be subjected to terms and conditions as may be mutually agreed upon by the parties;
4. The **Quezon City University** and **STIKES Bhakti Pertiwi Indonesia** shall exchange educational materials, research publications and instructional information beneficial to both parties;
5. The **Quezon City University** and **STIKES Bhakti Pertiwi Indonesia** shall explore the possibility of offering dual or joint-degree and non-degree programs subject to terms and conditions as may be mutually agreed by the parties.
6. The **Quezon City University** and **STIKES Bhakti Pertiwi Indonesia** shall promote and participate in the programs, projects and events organize and co-organize by its member institutions subject to terms and conditions as may be mutually agreed by the parties.



7. The **Quezon City University** and **STIKES Bhakti Pertiwi Indonesia** shall facilitate the exchange of experts as guest lecturers, visiting professors and resource speakers subject to terms and conditions as may be mutually agreed by the parties.

The terms and conditions specified in this mutual cooperation shall be discussed and agreed upon in writing by the appropriate responsible officers of both parties prior to the initiation of any particular program or activity.

This memorandum of agreement shall take effect upon signing thereof for a period of five (5) years. All amendments to this AGREEMENT and/or termination thereof shall be made upon mutual consent.
